

# **Nutshell Privacy Policy**

### 1. WHO WE ARE

We are Nutshell Packaging of Telford Road, Salisbury, Wiltshire, SP2 7PZ and we are a 'Data Controller' as defined by the GDPR regulations, in respect of personal information that we process in connection with our business. We respect individuals rights to privacy and for the security of the personal information that we hold. The purpose of our Privacy Policy is to explain how we collect and use personal information in connection with our business.

# 2. THE INFORMATION WE PROCESS
